FOR EACH ADDITIONAL TEN THOUSAND DOLLARS (\$10,000) OR FRACTION THEREOF OF GROSS ANNUAL PREMIUMS THE LICENSE WILL BE AN ADDITIONAL SEVENTY DOLLARS (\$70)

Provided, that the maximum license on such business, payable hereunder by any one company, society, association, corporation, firm or individual, shall not exceed twenty-one thousand dollars (\$21,000).

Each of the above named kinds of insurance contracts may be combined under one license tax by any such company, society, association, corporation, firm or individual, and the amount of the license tax shall be based on the combined gross annual premiums of all such business.

Provided, that the maximum license on such business, payable hereunder by any one company, society, association, corporation, firm or individual, shall not exceed nine thousand dollars (\$9,000).

Each of the above named kinds of insurance contracts may be combined under one license tax by any such company, society, association, corporation, firm or individual, and the amount of the license tax shall be based on the combined gross annual premiums of all such business.
